 In this NoR, 2019-2020 Japan-Palau Goodwill Yacht Race Executive Committee will hereby be referred to as Executive Committee, 2019-2020 Japan-Palau Goodwill Yacht Race Committee as Race Committee and 2019-2020 Japan-Palau Goodwill Yacht Race Protest Committee as Protest Committee.

1. Rules

1-1 The race will be governed by the rules as defined in The Racing Rules of Sailing 2017-2020 (RRS).

However, during the period from sunset to sunrise, instead of RRS Chapter 2, International Regulations for Preventing Collisions at Sea (IRPCAS) will be applied. The official sunset and sunrise times are stated in the sailing instructions.

- 1-3 ORC Rating Systems 2019.
- 1-4 JSAF Oceanic Race Rules.
- 1-5 World Sailing Offshore Special Regulations 2018-2019.
- 1-6 2019-2020 Japan-Palau Friendship Yacht Race Special Regulations (See Appendix 1).
- 1-7 In the NoR (under the provision of DP) the protest committee, can decide to give a lighter penalty than disqualification if they deem necessary /or at their discretion.
- 1-8 In the NoR (under the provision of NP) you cannot protest from the boat and you cannot request rescue.
 - This is an amendment to rule RRS 60.1 (a).
- 1-9 If there is a discrepancy between languages the Japanese language text will prevail/take precedence.

2. ADVERTISING [DP][NP]

If a participating boat displays advertising on team-equipment, boat or possessions, it must comply with the provisions of the World Sailing Advertising Code 20.3. In addition, when there is advertising by the organizer or an advertising contract with the sponsor, they are obligated to display advertising (stickers, flags, etc.) in predetermined positions based on the provisions of World Sailing advertisement regulation 20.4.1. From the front of the boom up to 20% may be used for sponsor advertising as designated by the organizer.

3. ELIGIBILITY

3-1 Eligible boats

- All boats must meet Category 2 of the OSR 2018-2019 rules. However, any items changed or added in the 2019 - 2020 Japan Palau Goodwill Yacht Racing Special Regulations will take precedence.
- 2) Monohull or Multihull sailboats registered in 2019 with JSAF. Overseas Monohull and Multihull sailboats with a current registration from their relevant national authorities.
- 3) Boats registered in Japan must have appropriate-inspection certificates. Overseas boats must satisfy the participation criteria and laws of the country in which they are registered.
- 4) A boat that has obtained a valid IRC certificate or ORC certificate when entering the IRC division or ORC division.
- 5) A boat with LH or LOA of 9m or more, or a boat permitted to participate by the race committee.

3-2 Owner of the boat

- 1) A group or individual member of the 2019 JSAF Oceanic Organization.
- 2) Participants from overseas must have valid qualifications from their relevant national authorities.

3-3 Skipper

- 1) A group or individual member of the 2019 JSAF Oceanic Organization.
- 2) Participants from overseas must have valid qualifications from their relevant national authorities.
- 3) Experience in no-port call sailing of 300 NM or more.
- 4) Skipper must sign and submit a Health Self-declaration Form and a Personal Sailing Record Declaration Form for all crew members including Skipper.
- 5) It is a requirement to take safety lectures conducted by the Executive Committee. The details of this course will be provided at a later date by the committee.
- 6) More than 30% of the crew (2 or more people) including the skipper have or are undertaking to complete training designated by the Executive Committee within five years, before the start of the race. (Three days course requirement).

3-4 Crews

- 1) 2019 JSAF members.
- 2) Participants from overseas must have valid qualifications with their relevant national authorities.
- 3) Overnight offshore sailing experience.
- 4) More than 30% of the crews must be experienced in offshore (non-stop) sailing of more than 150 NM.

4. ENTRY AND FORMS

4-1 Entry

Eligible boats may enter by paying the required entrance fee and submitting the following documents, a Completed Race Participation Fee Calculation Statement, copy of proof of payment i.e. Electronic Transfer Receipt (Form #1) along with a Boat profile picture and sending them to the following e-mail address by October 31, 2019.

- * Dual scoring for the IRC division and ORC division will be permitted.

6. RACE FLAG [NP]

- 6-1 The race flag will be the JSAF race flag.
- 6-2 The JSAF race flag needs to be taken down immediately when retiring from the race.

7. THE ESTABLISHMENT OF THE RACE

- 7-1 If there are more than 5 boats entered, the race can be conducted.
- 7-2 The finish of one boat or more in each class signals the completion of the race.

10. INSPECTIONS

Inspections are undertaken to maintain the fairness of the race and evoke the responsibility of the owner and the captain for their vessel.

Inspections are to take place before the start. Depending on the judgment of the race committee, inspections will also be carried out on all boats or those selected by random on completion of the race.

10-1 Inspection -1

1) Arrange an inspection date at the participating boat's home port of the or nearby.

- 2) Boats that do not pass inspection have the opportunity to fix and improve by inspection-2.
- 10-2 Inspection -2
 - 1) Arrange an inspection date at Yokohama port or nearby.
 - 2) Boats that fail inspection may be re-examined.
- 10-3 Inspections should be attended by two or more team members including the Skipper or one other person responsible for the vessel.
- 10-4 Boats failing reinspection at Inspection 2 will not be allowed to-participate further and the race participation fee will not be returned.

From Yokohama Port Yokohama Bay Bridge To Republic of Palau near Toachel Mlengui (West Passage)

(7°32.33N、27°31.81E)

13-2 Official race distance 1,726 nautical miles

14. CALCULATION OF ACHIEVEMENT

14-1 PHRF Division

Calculated by time on time by PHRF.

Boats with the lowest TCC time (after application of scoring penalties, if any) will be scored first if there is a boat of the same rank in CT.

14-2 IRC Division

Calculated by time on time by TCC.

Boats with the lowest TCC time (after application of scoring penalties, if any) will be scored first if there is a boat of the same rank in CT.

14-3 ORC Division

Calculated by time on distance.

The boat with the larger numerical value of GPH (after application of scoring penalties, if any) will be scored first if there is a boat of the same rank in CT.

15. SUPPORT BOATS

Use of support boat/s must be declared to the race committee in advance.

16. BERTHING

16-1 Yokohama port side: Yokohama Bayside Marina

16-2 Republic of Palau side: Republic of Palau private anchoring area *Details to follow from the race committee.

17. YOKOHAMA PORT ENTRANCE

Participating boats should enter Yokohama Bayside Marina by 12:00 noon Thursday, December 26, 2019.

18. RADIO COMMUNICATION [DP][NP]

- 18-1 Roll call will be carried out by satellite phone and is obligatory.
- 18-2 Details are described in the sailing instruction / communication regulations.
- 18-3 According to RRS 41: Boats may not receive any outside support or assistance. Communication systems & information equipment are not included in this ruling.

19. PRIZES

Prizes will be given as follows:

- 19-1 Division First Home Award
- 19-2 Winner of each division/class, second place, third place (Prizes will be adjusted according to the number of boats participating)
- 19-3 Other special prizes

20. DISCLAIMER OF LIABILITY

- 20-1 The race committee is solely responsible for the fair running and completion of the race.
- 20-2 Based on RRS 4, all boats and participants taking part in the race do so at their own risk and responsibility. Each organization and individuals, sponsors and those affiliated with sponsorship, administration, officials, cooperating partners, members and volunteers are not liable for any physical damage, disability or death caused before, during, or after the race.
 - *Crew members must acknowledge this, and release the Organising Authority, and their respective officers, employees, volunteers and members, from all liability by signing a disclaimer and acknowledgment of rights form, as supplied by the Organising Authority.

- 20-3 The boat has sole responsible for deciding whether to participate in the race or to continue the race. *The responsibility for a boat's decision to participate in a race or continue racing is hers alone according to RRS Fundamental Rule 4.
- 20-4 The race committee can refuse participation of boats, skipper or crew members at their discretion.

21. INSURANCE

During the race period, boats must also have effective insurance with comprehensive overseas coverage including the following;

- (1) Liability insurance
- (2) Passenger death/accident insurance
- (3) Search and rescue cost insurance
